Regulations that are due to become law soon will require that new sewers and lateral drains which connect to a public sewer must be adopted by the UK's sewerage companies.

Changes to sewer adoptions - Southern Water

The representatives can then ask Southern Water to make a declaration to adopt a sewer under Section 102 of the Water Industry Act 1991. Before adopting the sewer, Southern Water must first give notice to the owner(s) of the sewer. Only after two months have elapsed and no objections raised, may we adopt the sewer.

Property owners are no longer responsible for certain sewer pipes that connect their homes to public sewers. On 1 October 2011, legislation introduced by the government transferred responsibility for private sewers and lateral drains to Southern Water -providing clear ownership and better long-term maintenance for the sewer network.

Can I build over a public sewer? - South West Water

Nor should ground water be discharged into any public sewer or surface water discharged into the foul water system without the express permission of Southern Water. Buildings should be located at least three metres away from the diverted sewer where the depth from ground level to invert level is less than three metres.
