"By a girl, by a young woman, or even by an aged one, nothing must be done independently, even in her own house," states The Laws of Manu (Muller 1886:195).

Manusmriti, translated as "The Laws of Manu" or "The Institutions of Manu," is the most important and authoritative Hindu Law Book (Dharmashastra), which served as a foundational work on Hindu law and jurisprudence in ancient India at least 1500 years. Until the modern times, it was the standard reference for adjudicating civil and criminal cases by both the rulers who patronized Vedic faith and the people who practiced Hinduism.

### Manusmriti the Laws of Manu - Introduction

In the Laws of Manu, four social classes are mentioned, namely, 1) Brahmin, which are composed of priests and teachers, 2) Ksatriya, which are composed of kings, princes and warriors, 3) Vaisya, which are composed of tradesmen, and 4) Sudra , which are composed of workers or laborers.
